MEET & GREET

Arrival in Libya can prove disconcerting and dangerous to travellers. Not only facing risk from opportunistic criminals, but also bureaucratic hurdles and traffic dangers.

Clients using our “meet and greet” service can be assured that their personnel will be met by an experienced security consultant who will assist their arrival and take them safely on to their destination.

Our meet & greet operatives are efficient and professional. They understand the challenges clients might face, and how to avoid them.

Where permissible, client personnel are met at the aircraft door and escorted through all arrival formalities. On departure client personnel will be escorted to the aircraft door after being escorted through all the departure formalities.

Following the “meet and greet” we transport client representatives to their hotel or an agreed drop off point, using our trained drivers. While in transit to the hotel or drop-off point our consultant will provide either a general overview of the security environment or a formal safety briefing per client requirements.
